- ii) Any new bidder who have not participated in the earlier auction dated 4th January, 2017, can tender afresh offer in a sealed cover enclosing Bank draft/Pay Order drawn in favour of "OFFICIAL LIQUIDATOR, HIGH COURT, CALCUTTA" for an amount equivalent to 20% of the highest amount being received in respect of Lot-1 & 2 to the tune of Rs.6,10,000/-and Rs.6,40,000/- respectively or Rs. 1,22,000/- and Rs. 1,28,000/- respectively as earnest money deposit (EMD) and upon fulfillment of the terms and conditions regarding the sale and earnest money as per the earlier auction dated 4th January, 2017.
