The Official Liquidator will produce the best offer before the Hon’ble Judge taking company matters in the High Court at Calcutta when the matter will appear for confirmation of such sale. The successful purchaser shall have to take delivery/remove the goods from the subject premises within 15 (fifteen) days from the confirmation of sale or any other time as fixed by the Hon’ble Court after depositing the balance sale proceeds and proper compliance of the police Rule or any other Rule by local administration.
